With prior approval from your L.O., only entire matches may be made up, not individual games. Please note that matches need to be made up at least two weeks before the league ends.

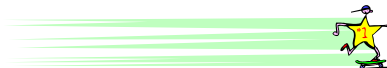
## ATTN SL-6's and SL-7's
